Woof Woof all you Karniverous Kanines;


Since this will be the last Woof-O-Gram prior to the end of the current fiscal year (June 30) please let me reiterate what is probably in several articles this issue. IF YOU PLAN TO ADVANCE TO PEDIGREED Devil Dog in August 2016, your paperwork MUST BE IN HANDS OF THE KENNEL DOG ROBBER no later than June 30, 2016. You also MUST BE REGISTERED at the National Convention with both the Marine Corps League and with Kennel Headquarters by 1700 on Monday. I can assure you if you do not complete these requirements by the deadline you will be dealing with the Chief Devil Dog and he will not be a happy camper. Attaining the high and honorable degree of Pedigreed Devil Dog is an honor, not a privilege. Make sure you complete your paperwork and get your Pack Dog Robber (or Pound Dog Robber if you have no Pack) to sign it, make a copy for you to carry with you, and get it in on time.

Those of you who will be elected or appointed to a Pound or Pack position during the coming months should plan to get and read a copy of the Kennel (and Pack / Pound as applicable) Bylaws, especially if you are attaining an Office for the very first time. Those who have been on a staff position before, elected or appointed to another Office should also do this to keep abreast of the latest changes. I am still surprised when I do this and something I forgot or skimmed over a previous time pops up. You should also get and read the Ritual. If you have a position that requires you to be part of a function that uses the Ritual, practice aloud before your events, this will help you with the actual presentation.

Also, while many Pounds and Packs have an individual who has been in that Office a long time should plan to have a couple Dogs who are familiar with the requirements of that Office on the sidelines in case the current incumbent is incapacitated. The good Lord will call for each one of us someday. Plan for the future. Get a couple of copies of the Dog Robber manual and read this as well.

I hope you have successful Division and Grand Growls, chew a few bones, and some fun!

Dogs throughout New England were very busy during November and December placing Toys for Tots boxes and later collecting the toys for distribution. PDD Laramee is responsible for conducting the Toys for Tots program for the whole Northern part of New Hampshire. Since this is a part of the state where trappers still make a living selling animal furs he has to be careful as he makes his rounds that one of the trappers doesn't mistake a devil dog for a game animal.

I continue to represent the Devil Dogs on the management board of the Building Dreams for Marines organization. The mission of the organization is to improve the quality of the lives of disabled Marines through modification to their homes, such as remodeling of kitchens and bathrooms to allow for the accommodation of wheelchairs, installing ramps, etc. Recently a dedication took place for a disabled Marine in New Hampshire where I proudly barked about the Devil Dogs.

Just prior to Christmas a number of dogs were spotted at the New Hampshire Veterans State Cemetery placing wreaths on the graves of veterans showing that the veteran isn't forgotten. While the next Marine Corps Birthday Luncheon is still 11 Months away a planning meeting of the Marine Expeditionary Brigade took place on whose board I serve representing the League and the Dogs.

Vermont Pound Keeper PDD Jim Chase reported that the dogs in Vermont held a very successful growl on 10 January with 12 dogs in attendance. Per my instructions Jim stated that he paid the two big bones for his faulty arithmetic in his last report. PK PDD Chase stated that bones were collected during the growl for dirty looks, snide comments, interrupting his words of wisdom, doing and saying nothing, mispronounced words and using non MODD terms. DD Rosato was fined a large bone for not very surreptitiously bouncing a tennis ball across the deck, thereby interrupting his chain of thoughts. All Packs and Pounds should develop active programs to encourage League Members who have been a member for at least one year to join the dogs. Don't forget to stay cognizant of the membership status of all dogs and the JVPK should be following up with all dogs whose membership lapses. The dogs require very little paper work (990N forms, transmittal forms, installation report and the submission of passport fees after every growl.



Get after those few Pounds who are dragging their paws submitting Passport Bones to the Kennel. Remember it is now a Kennel Bylaw requirement to submit Bones after EACH Pound Growl. If I don't see Bones being submitted, that means to me you are not holding Growls. That would also be a Bylaw violation. Pounds could have their Charters pulled. We don't want to lose any members, ask for assistance of your Pack Leader or me. We are here to assist local Pounds stay on track.

The CDD has asked every member of the Kennel to donate 1 addition Bone to the Passport Fund this year. 6000+ members = 6000+ Extra Bones to the Children's Hospital in Tulsa, OK this summer. That is 1 extra Bone for EVERY member of your local Pound. Submit them with your normal Passport Bones, just make a note so the

Kennel Dog Robber can track those donations.

It is that time of year again when anyone wishing to advance to PDD at the Supreme Growl in Tulsa needs to get their request to me. They must be in my hands prior to **July 1**. If the Advancement papers are not in on time you may be denied the opportunity to go through initiation and be obligated as a PDD. Please remember that the **Pack Dog Robber** must sign the request for advancement and that a copy should be kept by the Pack, Pound and by the individual Dog. Please bring your copy of the request with you as insurance against anything going wrong.

Please remember that the bylaws have changed. You must be in attendance by 5:00 PM on Monday.

Passport funds continue to arrive with many more Pounds contributing. However there are still way too many Pounds and Packs that have not sent in their bones. Pounds and Packs are required by the bylaws to hold at least 4 Growls per year. If you are holding the required Growls then the fee for stamping the passports should be sent in. The children's hospital in Oklahoma will be very grateful for your contribution.

I continue to receive Installation Reports with dates other than Sept through Nov. The bylaws state that Pound elections are to be held within that time period. We are not the same as the League.

All Packs and Pounds should be incorporated in order to protect themselves and to allow them to legally collect donations. Each should also have a EIN number from the IRS and be filing 990 forms annually. Send the information to the Kennel Dog Robber. If you do not file your taxes the IRS will revoke your tax exempt status. Trust me, you do not want to go through the hassle of all the paperwork and time to get re-established as a tax exempt organization. There is a new version of the Installation Report on the Kennel web site and new hard copy forms will be available shortly. Please use them.

Many members have still not renewed their membership for 2016. Dog Robbers: Please follow up on this and get them paid!

Three major awards are presented at the Supreme Growl, Kennel Dog of the Year, Kennel Pound Dog Robber of the year and Kennel Pack Dog Robber of the year. Nominations have been pitiful! If you have a Dog that you think is worthy of this honor, please take the time to make the submission. Follow instructions in the bylaws and get them to me prior to July 20.

Existing Wording:

Section 309(B) - Pack Officers - Elected and Appointed Staff

The Appointed Officers of the Pack shall be the Worthy Pack Dog Robber, Worthy Pack Watch Dog and the Worthy Pack Barking Dog, and such other subordinate officers as the Worthy Pack Leader may choose to appoint. It is preferable that the Worthy Pack Leader-elect make the appointments following the election so as to permit the installation of the full staff of officers. The Appointed Officers shall serve only at the convenience and pleasure of the Worthy Pack Leader.

Proposed Wording:

Section 309 (B) - APPOINTED - The Appointed Officers of the Pack shall be the Worthy Pack Dog Robber, Worthy Pack Watch Dog, Worthy Pack Barking Dog and the Worthy Pack Quartermaster; and, such other subordinate officers as the Worthy Pack Leader may choose to appoint. It is preferable that the Worthy Pack Leader-elect make the appointments following the election so as to permit the installation of the full staff of officers. The Appointed Officers shall serve only at the convenience and pleasure of the Worthy Pack Leader.

Rationale:

The Worthy Pack Quartermaster appears to have never been incorporated into the roster of appointed Pack Officers. Despite that lack of definition, the Worthy Pack Quartermaster position has, in most cases, become one of increasing responsibility and significance. In some cases, that Pedigreed Devil Dog has responsibility for substantial quantities of Devil Dog gear for resale and is generally the custodian of considerable amounts of bones from which replacement Devil Dog gear purchases are made, with sizable numbers of bones recouped with the sale of merchandise by the Worthy Pack Quartermaster.

Proposed Bylaw Amendment #3

MILITARY ORDER OF THE DEVIL DOGS, INC. BYLAWS ARTICLE IV — THE KENNEL

Proposed Re-alignment of Kennel Officers – Duties to more closely define and categorize the office of the Honorable Kennel Executive Director. Where the approved/amended 2015 Kennel ByLaws delineate the duties of the Honorable Kennel Executive Director in Section 412 – Kennel Officers - Duties, Subparagraph (D); this proposal would re-designate that definition as Section 412 – Kennel Officers - Duties, Subparagraph (E)

Existing Wording:

Section 412 – Kennel Officers - Duties, Subparagraph (D) - the Honorable Kennel Dog Robber/Honorable Kennel Executive Secretary

412 (D) (2). The Honorable Kennel Executive Director shall be responsible to the Honorable Chief Devil Dog and the Kennel and shall be the custodian with the Honorable Chief Devil Dog, of all monies, property, securities and investments of the Kennel. The Honorable Kennel Executive Director shall keep on deposit in a reputable bank, all monies and securities of the Order, and shall make all disbursements for all accounts owing when approved by proper authority, by check, which shall be countersigned by the Honorable Chief Devil Dog. They shall perform such duties customarily executed by recording secretaries, financial secretaries and treasurers. They shall make a full and correct accounting and report, including financial statements, to each Supreme Growl of the Kennel and at such other times as may be directed by the Honorable Chief Devil Dog or the Kennel Staff. They shall forward an up-to-date financial report to all members of the Kennel Staff, all Worthy Pack Leaders. all Worthy Pack Dog Robbers, all Pound Keepers, and all Pound Dog Robbers semiannually, and shall perform such other duties as may be assigned by the Honorable Chief Devil Dog, or by other competent authority. They shall serve as the Secretary and Treasurer of the Corporation.

412 (D) (3). The office of Honorable Kennel Deputy Executive Director shall to assist The Honorable Kennel Executive Director in all functions and responsibilities assigned to The Honorable Kennel Executive Director.

Proposed Re-designation:

Section 412 - Kennel Officers – Duties, The Honorable Kennel Executive Director 412 (E) (1) The Honorable Kennel Executive Director shall be responsible to the Honorable Chief Devil Dog and the Kennel and shall be the custodian with the Honorable Chief Devil Dog, of all monies, property, securities and investments of the Kennel. The Honorable Kennel Executive Director shall keep on deposit in a reputable bank, all monies and securities of the Order, and shall make all disbursements for all accounts owing when approved by proper authority, by check, which shall be countersigned by the Honorable Chief Devil Dog. They shall perform such duties customarily executed by recording secretaries, financial secretaries and treasurers. They shall make a full and correct accounting and report, including financial statements, to each Supreme Growl of the Kennel and at such other times as may be

directed by the Honorable Chief Devil Dog or the Kennel Staff. They shall forward an up-to-date financial report to all members of the Kennel Staff, all Worthy Pack Leaders, all Worthy Pack Dog Robbers, all Pound Keepers, and all Pound Dog Robbers semi-annually, and shall perform such other duties as may be assigned by the Honorable Chief Devil Dog, or by other competent authority. They shall serve as the Secretary and Treasurer of the Corporation.

412 (E) (2) The office of Honorable Deputy Kennel Executive Director shall assist The Honorable Kennel Executive Director in all functions and responsibilities assigned to The Honorable Kennel Executive Director.

Rationale:

At the 76th Supreme Growl in 2015, the Kennel ByLaws were amended to retitle the office of the Honorable Kennel Executive Secretary as the Honorable Kennel Executive Director. This amendment is simply a house-keeping chore intended to place the Honorable Kennel Executive Director and Honorable Deputy Kennel Executive Deputy into a subparagraph by themselves, rather than leave that office included in the job description for the Honorable Kennel Dog Robber. All other Honorable Kennel Appointed Officers are delineated in separate subparagraphs.

Proposed Bylaw Amendment #4

MILITARY ORDER OF THE DEVIL DOGS, INC. BYLAWS ARTICLE XIII. Section 1301 (A) — AMENDING OF BYLAWS

Existing Wording:

Section 1301 - Method of Amending

A. All Devil Dogs, Pounds and Packs may seek to revise repeal or amend these Bylaws by submitting their proposals in typewritten or legible form, using the exact wording intended for the change, to the Honorable Kennel Smart Dog <u>no later than 1 March</u> prior to the opening date of the Supreme Growl of the Kennel at which their proposals are to be considered. All proposals must contain the identity of the maker or submitter, otherwise they will not be considered. The Honorable Kennel Smart Dog will propagate the proposals without comment by having the Honorable Kennel Barking Dog publish all proposals in the Woof-O-gram, the Order's house organ, and/or by mailing all proposals to each Pound Keeper and Pack Leader. In both cases, the proposed changes shall be distributed so that they are received by each Pack Leader and Pound Keeper no later than <u>1 May prior</u> to the opening date of the Supreme Growl of the Kennel at which such proposed revision, repeal or amendment is to be considered. The said notice shall include the proposed changes to the Articles, Sections and Paragraphs to be revised, repealed or amended. In addition to this, proposed changes may be posted on an official Kennel Web Site in their entirety.

Proposed New Wording:

A. All Devil Dogs, Pounds and Packs may seek to revise repeal or amend these Bylaws by submitting their proposals in typewritten or legible form, using the exact wording intended for the change, to the Honorable Kennel Smart Dog no later than 15 March prior to the opening date of the Supreme Growl of the Kennel at which their proposals are to be considered. All proposals must contain the identity of the maker or submitter, otherwise they will not be considered. The Honorable Kennel Smart Dog will propagate the proposals without comment by having the Honorable Kennel Barking Dog publish all proposals in the Woof-O-Gram, the Order's house organ, and/or by mailing all proposals to each Pound Keeper and Pack Leader. In both cases, the proposed changes shall be distributed so that they are received by each Pack Leader and Pound Keeper no later than 15 May prior to the opening date of the Supreme Growl of the Kennel at which such proposed revision, repeal or amendment is to be considered. The said notice shall include the proposed changes to the Articles, Sections and Paragraphs to be revised, repealed or amended. In addition to this, proposed changes may be posted on an official Kennel Web Site in their entirety.

Rationale:

Because the date(s) of the Marine Corps League Mid-Winter Conference/MODD Mini-Growl now fall into the month of March, it is necessary to extend the deadline – by two weeks – for submission of proposed amendments to the Kennel ByLaws, also requiring a two-week extension of the date by which the Honorable Kennel Smart Dog is required to distribute the proposed changes to each Pack Leader and Pound Keeper prior to the opening date of the Supreme Growl of the Kennel at which such proposed revision, repeal or amendment is to be considered.

The Marines at the 2013 National Convention, voted on and approved FMF Chaplain's to be regular members of the Marine Corps League having all rights and privileges of regular members.

<u>Proposed Bylaw Amendment # 6</u> <u>Section 507 – Incorporation</u>

Existing Wording:

Incorporation is not required of Packs and Pounds; however, they are encouraged to incorporate in accordance with the provisions of the state in which they are located, for the mutual protection of all concerned. As a subsidiary of the Marine Corps League, the ORDER and its subordinates are covered under the blanket IRS determination. The applicable IRS regulation for this determination is 501 (c) 4.

Proposed Wording:

Incorporation is required in all Packs and Pounds. As a subsidiary of the Marine Corps League, the ORDER and its subordinates are covered under the blanket IRS determination. The applicable IRS regulation for this determination is 501 (c) 4. Effective immediately, any Pack or Pound which has not provided the Honorable Kennel Dog Robber, with proof of its incorporation by January 1, 2018, will be billed in the amount of seventy-five (\$75.00) dollars and a like amount annually until such proof of incorporation is on file with the Honorable Kennel Dog Robber. All fines will be forwarded to the National Headquarters, Marine Corps League, Inc.. A Pound which fails to remit its payment to the Kennel Dog Robber shall be in default as is provided in Article Two, Section 218 – **POUND DEFAULT.** A new Pound will have two (2) years from the issue date of their new charter.

Rationale:

MCL Bylaws

SECTION 700 - AUTHORITY - All subsidiary organizations and subordinate groups which, and in the future, shall function and operate directly or indirectly under the Congressional Charter and name of the Marine Corps League are and shall ever be subject to the authority, supervision, direction, control, and discipline of the Marine Corps League.

- (a) Such organizations and groups may:
- (1) Adopt Bylaws not incompatible or inconsistent with the Bylaws and Administrative Procedures of the Marine Corps League.

(2) Incorporate, if said incorporation identifies them by name with the Marine Corps League and acknowledges their accountability to the Marine Corps League. Such organizations and groups which are incorporated **NOT** in this manner, shall immediately implement the amending of their incorporation and submit the proposed amended incorporation to the National Judge Advocate of the Marine Corps League for review, consideration, and approval.

(b) Such subsidiary organizations and subordinate groups shall conduct their business in such a manner as will demonstrate a cheerful cooperation with all units and levels of the Marine Corps League and the general public; and all levels and units of the Marine Corps League shall reciprocate in a like manner.

SECTION 710 - INCORPORATIONS - Any of the foregoing, including Departments and Detachments, which engage in services or business, either profit or non-profit, or which use the name of the Marine Corps League will be incorporated in accordance with **SECTION 700** of this Article. Effective June 30, 2000, each Department, or Detachment, which has not provided National Headquarters, Marine Corps League, Inc., with proof of its incorporation will be billed in the amount of seventy-five (\$75.00) dollars and a like amount annually until such proof of incorporation is on file with National Headquarters. A Department, or Detachment, which fails to remit its payment to National Headquarters shall be in default as is provided in Article Four, Section 420 - **DEFAULT.** A new Department or Detachment will have two (2) years from the issue date of their new charter.

Section 319 – Pack Default

A Pack shall be in Default if:

It is indebted to the Kennel

It does not have a valid Installation Report on file with Kennel by 30 June.

No OFFICER of a Defaulted Pack may serve as a Kennel Officer.

Notification of any Pack without an Installation Report must appear in the Spring Edition of the WOOF-O-GRAM.

Rationale:

Article II, Section 218 of the current by-laws addresses the possible Default of a Pound. Under Article three of the current By-laws, there is no Section that addresses the possibility of a Pack as being in Default , or sets the parameters for the Default. This will assure that the Pack responsibility is not exceeded by that of the Pound . This needs to be added to ensure the same level of responsibility for the Pack.
